
Dear Attorney Rocha:

In accordance with the Hospital Conversions Act (“HCA”), R.I. Gen. Laws §23-17.14-1, et seq., the Rhode Island Department of Health (“RIDOH”) and the Rhode Island Office of the Attorney General (“Attorney General”) have reviewed the Hospital Conversions Initial Application in the above-entitled matter. We notify you in your capacity as legal counsel to the Transacting Parties that RIDOH and the Attorney General hereby deem the Hospital Conversions Application that was filed on November 14, 2023 and supplemented on December 12, 2023 to be complete and accepted for review. The review period under the HCA will commence tomorrow, December 15, 2023.

Each agency will issue supplemental questions under separate cover. The Attorney General will also contact you in the coming weeks regarding confidentiality determinations. Please be aware that once a confidentiality determination is issued, the Transacting Parties will be required to submit a final copy of the complete application to each agency in order for the public version to be posted for public review.
